

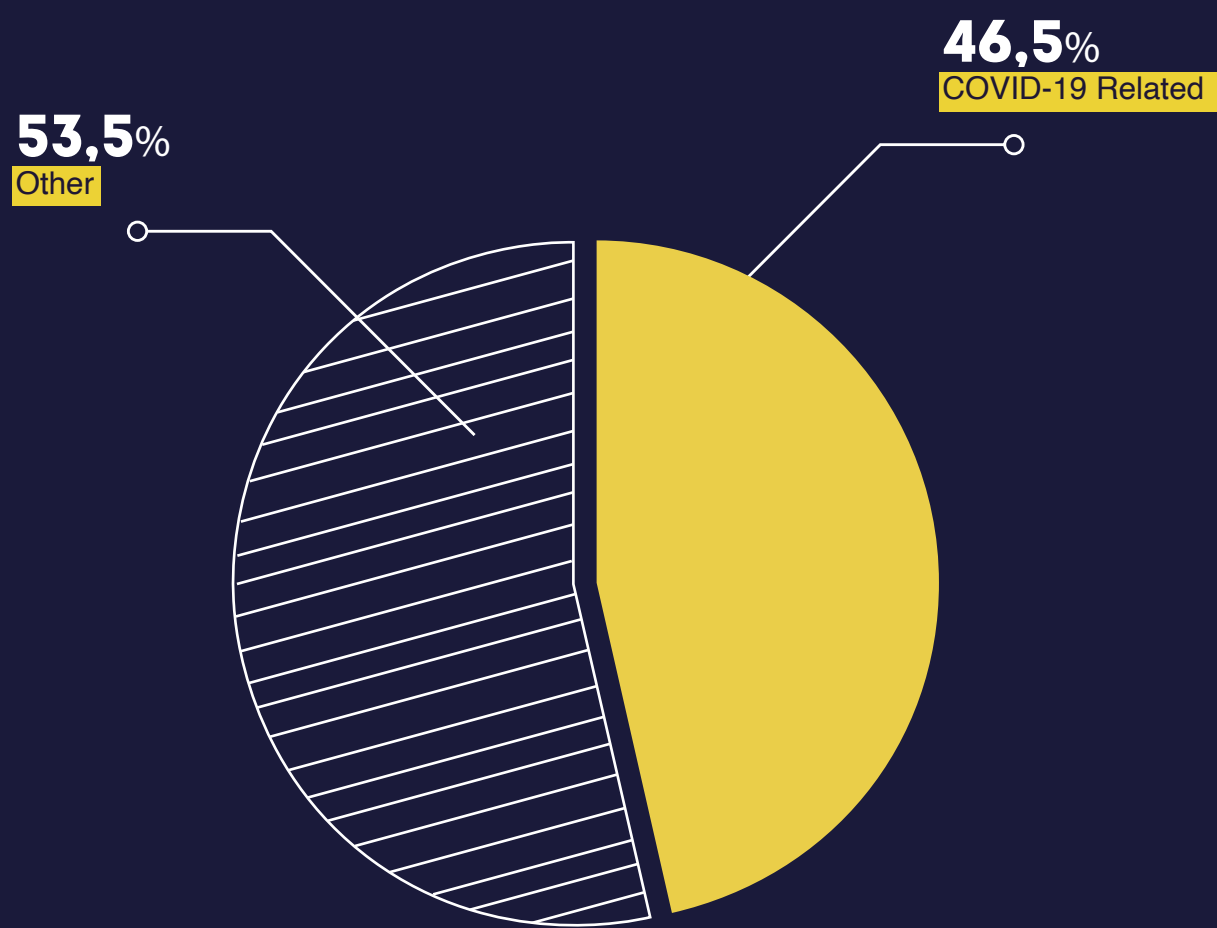

COVID-19 RELATED DISINFORMATION IS STILL STRONG, BUT SEEMS TO BE LOSING MOMENTUM

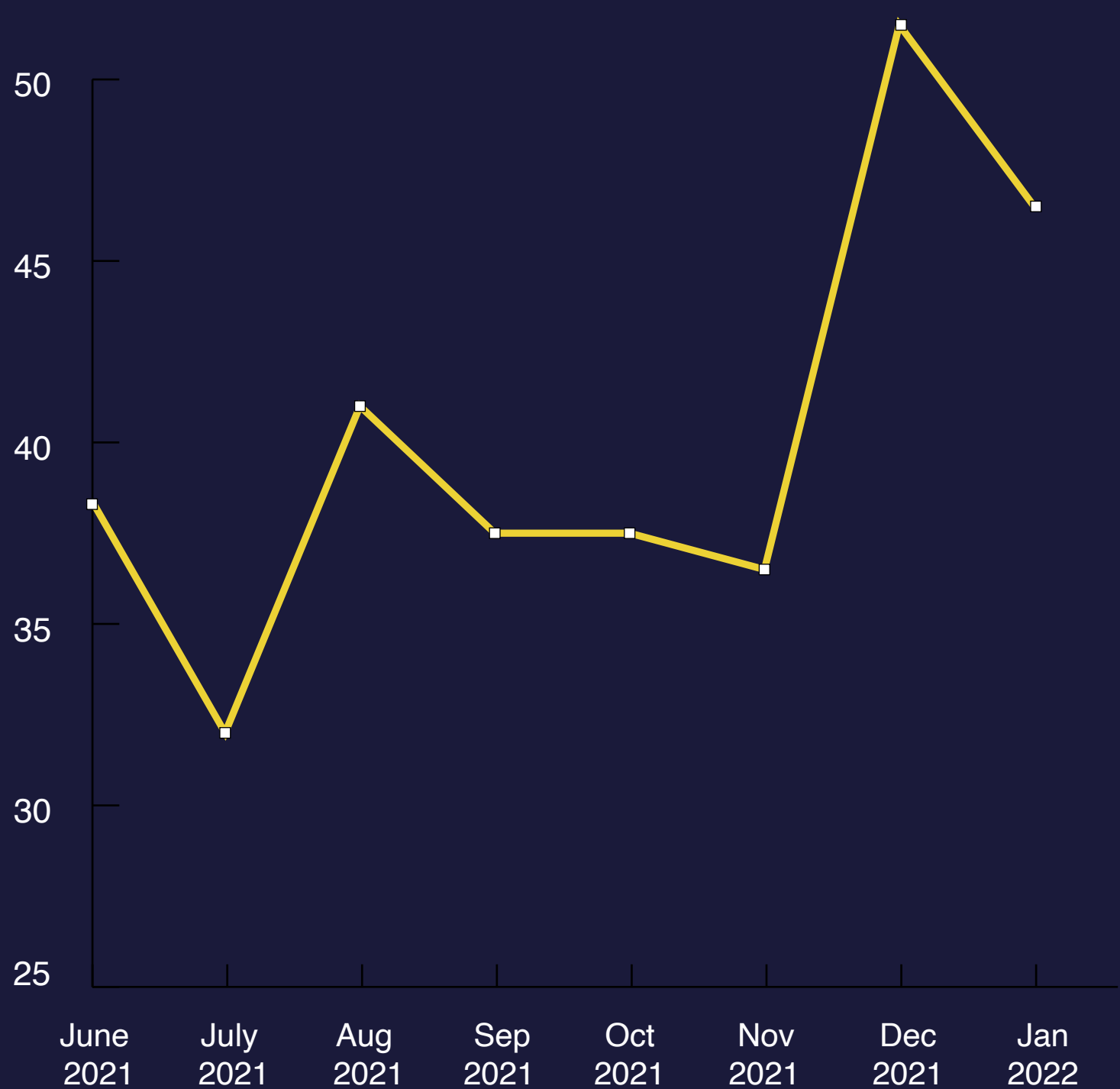
Monthly brief no. 8 – EDMO fact-checking network

COVID-19 RELATED DISINFORMATION IS STILL STRONG IN JANUARY 2022



The 13 organizations* part of the EDMO fact-checking network that contributed to this brief published a total of 1.025 fact-checking articles in January 2022. Out of these articles, 476 (46.5%) focused on COVID-19 related disinformation.

This percentage is the second highest ever recorded by these briefs, but lower than the one recorded the month before (51.5%). This decrease seems to be more related to some specific country-related situations (eg. Parliamentary elections in Portugal) than to a decline in the COVID-19 related disinformation. But it's noteworthy that there hasn't been an ulterior growth.

SAME OLD NAMES, SAME OLD HOAXES

In January 2022, according to the information gathered by the 13 organizations part of EDMO fact-checking network who contributed to this brief, the COVID-19 related disinformation didn't evolve significantly.

The “heroes” of anti-vaxxers narrations this month are old acquaintances of disinformation: eg. the American scientist Robert Malone, the German lawyer Reiner Füllmich, the French professor Christian Perronne and the Thai-German microbiologist Sukarit Bakhdi.

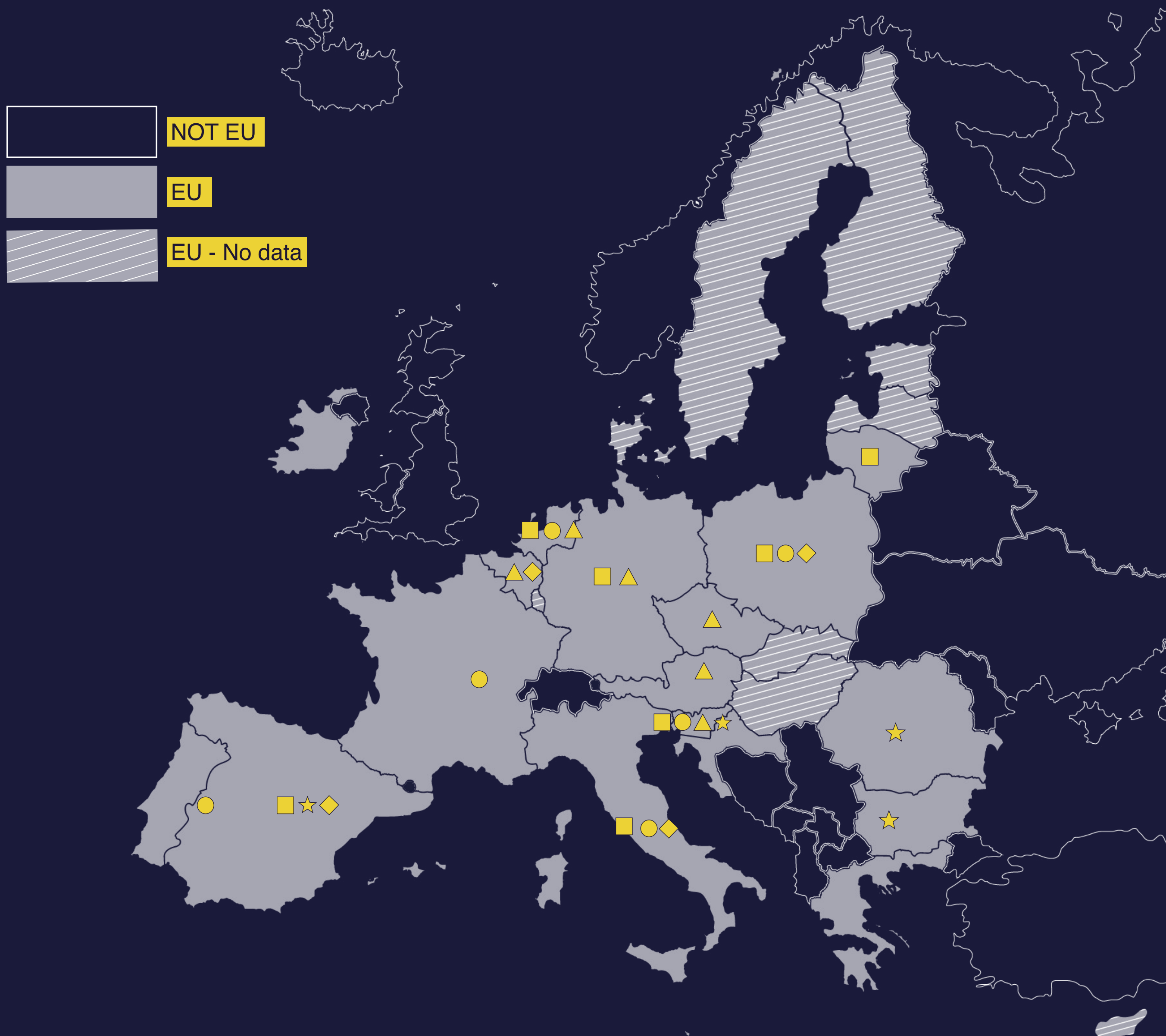
The false stories circulating this month are similar to the ones already seen circulating previously:

- Face-masks cause a serious lack of oxygen and a concentration of CO₂ that could lead to death
- Vaccines are ineffective: the majority of patients in ICU are vaccinated
- Vaccinated people are more susceptible for catching Omicron
- COVID-19 patients are actors paid to simulate the disease
- It is scientifically demonstrated that Ivermectin is effective against COVID-19
- There is an exponential rise in the number of myocarditis and pericarditis cases because of the COVID-19 vaccines



THE FIVE FALSE STORIES WITH THE WIDEST CIRCULATION IN THE EU IN JANUARY, BASED ON THE EU FACT-CHECKERS REPORTS, WERE:

- Insurance companies deny compensation for the death of vaccinated people if they die because of the COVID-19 vaccine
- A video collage of 23 athletes collapsing because of the COVID-19 vaccine
- ▲ British authorities admitted that the COVID-19 vaccines have permanently damaged people's natural immune system
- ★ Antigen tests for Covid-19 are not reliable and it's demonstrated via a video showing a test giving a positive result for freshly squeezed orange juice
- ◆ Tennis players have dropped out of the Australian Open tournament due to health problems caused by the COVID-19 vaccination



UKRAINE RELATED DISINFORMATION

Analyzing the information gathered by the 13 organizations part of EDMO fact-checking network that contributed to this brief, we detected the circulation of some false news about the situation in Ukraine, especially in Spain, Portugal, Poland and Romania.

For example:


- Germany blocked flights of British planes with military equipment for Ukraine amid soaring tensions with Russia (seen in Poland)
- A BBC video warning of an imminent nuclear war (seen in Portugal)
- A video showing the Ukrainian military preparing for a war with Russia (seen in Spain)
- A video compilation of war images implying that the war between Russia and Ukraine had already started (seen in Spain)
- A video showing a convoy of US tanks in Romania (seen in Romania)

The size and the nature of this disinformation doesn't seem to be coherent with a state-sponsored operation. It looks mostly like click-baiting that exploits a hot topic in the news.




THE MOST SIGNIFICANT VERIFIED DISINFORMATION STORIES AT THE NATIONAL LEVEL:




 **SPAIN:**
Poland, Sweden and Norway are filing a lawsuit against the WHO for infecting Europe: some pilots admitted that they have sprayed a chemical product



 **POLAND:**
People who are fully vaccinated will have AIDS by the end of January



 **IRELAND:**
Anyone who has ever had a cold is sufficiently protected against Covid-19 and doesn't need a vaccine

METHODOLOGY

The information contained in this brief was collected via a questionnaire sent to the fact-checking organizations that are part of the *EDMO* fact-checking network
