

DISINFORMATION IN JANUARY SUGGESTS THAT THE EU OVERTURNS NATIONAL ELECTIONS

DISINFORMATION ABOUT CLIMATE CHANGE REGAINS TRACTION, DISINFORMATION ON MIGRATION-RELATED ISSUES DOUBLES


The 37 organizations* part of the EDMO fact-checking network that contributed to this brief published a total of 1.642 fact-checking articles in January 2025. Out of these articles, 100 (6%) focused on Ukraine-related disinformation; 150 (9%) on climate change-related disinformation; 95 (6%) on disinformation related to the EU; 28 (2%) on the Middle Eastern regional conflict; 72 (4%) on COVID-19-related disinformation; 108 (7%) on disinformation related to immigration; and 26 (2%) on disinformation about LGBTQ+ and gender issues.

Disinformation about climate change increased by three percentage points in January, making the climate crisis the most targeted issue of the month by false stories. The number of baseless claims about migration-related issues also grew, with the related percentage more than doubling compared to December 2024.

The percentage of disinformation related to the war in Ukraine decreased slightly, as did false stories on COVID-19-related issues. The shares of false information about the other constantly monitored topics remained almost stable or showed only minor fluctuations.



CALIFORNIA BURNS, DISINFORMATION GOES VIRAL

Massive <u>wildfires devastated</u> Southern California in January and, as it happened <u>in the context of other climate disasters</u> in recent years, false stories tried to exploit the situation. Social media <u>have been flooded</u> with a variety of claims proven false by independent fact-checkers and publicly available evidence, trying to convey propaganda messages and conspiracy theories.

First of all, <u>out-of-context images and videos</u> have been used to attract the attention of social media users, along with a number of <u>Al-generated items</u> (see slide 6). By blaming them for starting the fires, false information also sought to incite hatred against specific minorities: baseless claims suggested that the fires were started by "illegal immigrants" (<u>also accused of stealing in evacuated houses</u>), that <u>the alleged LGBTQ+leadership of the local fire department</u> was to blame or that the situation <u>was badly managed</u> because of the <u>diversity and inclusion programs</u>, a rhetoric also <u>adopted by US President Donald Trump</u>. Conspiracist content suggested that <u>strange meteorological phenomena</u>, <u>laser beams</u>, <u>chemtrails</u>, and <u>energy weapons</u> were used to deliberately start or <u>control the fires</u> in order to destroy the area and <u>make way for smart city projects</u>. At the same time, since the fires also hit <u>very rich neighborhoods</u>, false claims suggested that some villas burned down <u>belonged to Ukrainian high-level officials</u> or the <u>German Chancellor Olaf Scholz</u>, in an attempt to depict them as living a luxurious life.

As usual in the wave of extreme meteorological events, <u>climate denialism</u>, false stories alleging the <u>ineffectiveness</u> and <u>dangerousness</u> of climate measures, and <u>conspiracy</u> <u>theories</u> resurfaced.



THE EU IS WEAK AND ANNULS NATIONAL ELECTIONS, DISINFORMATION SUGGESTS



A <u>widespread false story circulated in various</u> countries that the former EU commissioner Thierry Breton admitted that EU institutions were behind the <u>annulment of the Romanian elections</u> and that similar actions <u>will be taken in Germany</u>, where elections will be held on February 23, if the far-right party AfD wins. Baseless information suggests that <u>massive demonstrations are ongoing</u> in Romania against the EU and NATO for this reason.



With federal elections approaching, <u>disinformation campaigns</u> are running in Germany, <u>especially around migration</u>. Social media posts falsely alleged that President Frank-Walter Steinmeier <u>threatened to annul the elections if the AfD performed too well</u>. False stories also involved the AfD party with <u>decontextualized surveys</u> and claims exaggerating the <u>support</u> it has or accusing mainstream media of <u>deliberately excluding alleged anti-EU protests</u> and <u>AfD itself</u> from their coverage.




In general, the EU is depicted by disinformation as authoritative, <u>corrupted</u> and willing to impose unreasonable measures on citizens, such as <u>extra-taxing deposits</u>, <u>banning cotton</u>, or <u>forcing citizens</u> to eat <u>insects and harmful substances</u>. Also <u>pro-EU leaders</u> are <u>similarly targeted</u>, while disinformation targets <u>female politicians attempting</u> to <u>undermine</u> their leadership. The European community is also depicted as weak by a false story claiming that Karsten Hønge, a <u>prominent Member of the Danish Parliament</u>, addressing Trump's will to annex Greenland, suggested asking for the help of Russia. This specific false claim has been tracked in Denmark, <u>Greece</u>, <u>Bulgaria</u>, <u>Estonia</u>, <u>Slovakia</u> and in various EU languages such as <u>German</u>, <u>French</u>, <u>English</u>, <u>Spanish</u>, <u>Portuguese</u>, and <u>Romanian</u>.




AI-GENERATED DISINFORMATION

The percentage of disinformation stories using Al-generated content increased in January, mostly due to digitally-generated content about the California wildfires. Out of 1.642 fact-checking articles, 128 addressed the use of this technology in disinformation, representing 8% of the total. This figure is the highest ever recorded since EDMO began the dedicated monitoring in March 2023.



Among the most widely circulated hoaxes in January (see slide 7) are generated or digitally altered images and videos of the Hollywood sign engulfed in the flames. In general, AI has been largely exploited to spread dramatic and alarmistic content about the California wildfires: viral AI-generated images falsely showed a house miraculously untouched by the fires, allegedly because a "Christian family" lived there, a church left unscathed while everything else around it was destroyed. AI has also been used to promote political propaganda, as in the case of generated images depicting the president of Russia, Vladimir Putin, or migrants allegedly deported by the Trump administration. In the US, TikTok has been flooded with deepfakes of Donald Trump and Elon Musk spreading motivational messages.







THE FOUR FALSE STORIES WITH THE WIDEST CIRCULATION IN THE EU IN JANUARY, BASED ON THE FACT-CHECKERS' REPORTS, WERE:

- Video/images of the <u>Hollywood sign on fire</u> during the fire emergency in LA
- Ice at the South Pole grew by 17% since 1979, therefore climate change is not real
- ▲ Zelensky <u>purchased</u> a 436 square meter villa with underground bunkers on the Caribbean island of Saint Barthelemy
- Putin <u>has asked</u> the US to extradite Fauci for "crimes against humanity"
